#### Description

INVITATION TO BID FOR Supply, Delivery of Materials for Relocation of Water Meter, Hydrant and Pipe affected by DPWH Road Widening Project

1. The Calabanga Water District, through the Corporate Budget of 2020 intends to apply the sum of P1,724,879.12 being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Materials for Relocation of Water Meter, Hydrant and Pipe affected by DPWH Road Widening Project. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Calabanga Water District now invites bids for Procurement of Materials for Relocation of Water Meter, Hydrant and Pipe affected by DPWH Road Widening Project. Delivery of the Goods is required 15 calendar days upon receipt of notice of award. Bidders should have completed, within 3 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from Calabanga Water District and inspect the Bidding

Documents at the address given below during 8:00 to 5:00 PM Monday to Friday.

5. A complete set of Bidding Documents may be acquired by interested Bidders on July 20, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Php5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Calabanga Water District will hold a Pre-Bid Conference on July 27, 2020 10:00 AM at CAWADI Bldg. San Antonio, Calabanga, Camarines Sur, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before August 7, 2020 1:00 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on August 7, 2020 2:00 PM at CAWADI Bldg. San Antonio, Calabanga, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
