1. The CALABANGA WATER DISTRICT, through the Corporate Budget CY 2022 intends to apply the sum of 1,600,000.00 [1. Distribution Line Expansion at Brgy. Manguring to Bonot Gawad Kalinga (500,000.00), 2. Distribution Line Expansion at Brgy. Bigaas to Pagatpat (350,000.00), 3. Distribution Line Expansion at Brgy. Cabanbanan (400,000.00), 4. Distribution Line Expansion at Brgy. San Roque Nazareno Home Village (350,000.00)] being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The CALABANGA WATER DISTRICT now invites bids for the above Procurement Project. Completion of the Works is required One hundred fifty days (150). 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from CALABANGA WATER DISTRICT and inspect the Bidding Documents at the address given below from 9:00 AM to 4:00 PM.

A complete set of Bidding Documents may be acquired by interested bidders on January 24, 2022 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Pnp5,000.00.

The CAWADI BAC will hold a Pre-Bid Conference on January 31, 2022, 10:00 A.M. at the CAWADI Bidding Room, San Antonio, Calabanga, Camarines Sur and/or through videoconferencing/webcasting via zoom application in case community quarantine or similar restrictions due to COVID 19 is in effect. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

Bid opening shall be on February 11, 2022 at 2:00 P.M. at the at the CAWADI Bidding Room, Calabanga, Camarines Sur and/or through videoconferencing/webcasting via zoom application in case community quarantine or similar restrictions due to COVID 19 is in effect. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
