- The CALABANGA WATER DISTRICT now invites bids for the above Procurement Project. Completion of the Works is required One hundred eighty days (180). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bid opening shall be on March 09, 2022 at 2:00 P.M. at the at the CAWADI Bidding Room, Calabanga, Camarines Sur and/or through videoconferencing/webcasting via zoom application in case community quarantine or similar restrictions due to COVID 19 is in effect. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
