1. The CALABANGA WATER DISTRICT through the Corporate Budget F/Y 2022 intends to apply the sum of Php7,972,000.00 [Drilling of One (1) Exploratory/Production Well at Brgy Camuning - Php2,731,000.00], [Drilling of One (1) Exploratory/Production Well at Brgy Paolbo & Installation of Solar Power, Pump and Accessories - Php5,241,000.00] being the Approved Budget for the Contract (ABC) to payments under the contract for PB-2022-07-001. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CALABANGA WATER DISTRICT now invites bids for the above Procurement Project. Completion of the Works is required One hundred eighty days (180). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from CALABANGA WATER DISTRICT and inspect the Bidding Documents at the address given below from 9:00 AM to 4:00 PM.

5. A complete set of Bidding Documents may be acquired by interested bidders on July 27, 2022 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos Php10,000.00.

6. The CAWADI BAC will hold a Pre-Bid Conference on August 4, 2022, 10:00 A.M. at the CAWADI Bidding Room, San Antonio, Calabanga, Camarines Sur and/or through videoconferencing/webcasting via zoom application in case community quarantine or similar restrictions due to COVID 19 is in effect. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity

7. Bids must be duly received by the CAWADI BAC Secretariat through (i) manual submission, or (ii) delivery by duly registered courier service in case community quarantine or similar restrictions due to COVID 19 is in effect, at the CAWADI Bidding Room, Calabanga, Camarines Sur on or before August 16, 2022, 1:00 P.M. The Procuring Entity shall allow the Bidder to present its proof of payment for the courier service by transmitting it electronically to the CAWADI's designated official email account. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on August 16, 2022 at 2:00 P.M. at the at the CAWADI Bidding Room, Calabanga, Camarines Sur and/or through videoconferencing/webcasting via zoom application in case community quarantine or similar restrictions due to COVID 19 is in effect. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

10. The CAWADI BAC reserves the right to suspend the procurement proceedings during the existence of community quarantine or similar restrictions due to COVID 19 pursuant to GPPB Resolution No. 09-2020 dated May 7, 2020.

11. The CALABANGA WATER DISTRICT reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
