Distribution Line Expansion at Brgy. Manguring Zone 2 and Zone 7 (800,525.00), being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The CALABANGA WATER DISTRICT now invites bids for the above Procurement Project. Completion of the Works is required One hundred twenty days (120).
