- The CALABANGA WATER DISTRICT, through the Corporate Budget CY 2023 intends to apply the sum of 1,500,000.00 being the ABC to payments under the contract for PB-2023-08-008. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CALABANGA WATER DISTRICT now invites bids for the above Procurement Project. Delivery of the Goods is required in Section IV Schedule of Requirements of the Bids Documents. Bidders should have completed, within 3 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bid opening shall be on September 4, 2023 2:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
